- AB 386, as amended (Levine): Public postsecondary education: Cross-enrollment: Online education at the California State University.
Action: Support
- AB 387, as amended (Levine): Public postsecondary education: California State University: Online education. **Action: Support**
- AB 895, as amended (Rendon): Postsecondary education: Online Education Task Force.
Action: Support



Legislative bills on online learning

- SB 440 (Padilla). Public postsecondary education: Student Transfer Achievement Reform Act. **Action: Oppose**
- SB 520, as amended (Steinberg). Student instruction: California Online Student Access Platform. **Action: Oppose unless amended**
- SB 547 (Block). Public postsecondary education: Online courses. **Action: Support**
